 - c) Medical certificate in respect of Orthopedically Handicapped.
 - d) Course completion certificate (wherever applicable) from Registrar/Dean/Principal of the organization.
 - e) A set of attested photocopies of all the above certificates may be brought along at the time of counseling.
 - f) ID proof (Aadhar Card)
6. The subject of the students shall not be changed once admission has taken place and the fee is deposited. Fee should be deposited at the time of counselling.
