SUB: CORRECTION IN THE BANK ACCOUNT DETAILS FOR RECEIVING SCHOLARSHIP

The UGC has given an opportunity to students to correct their bank account details. Based on the information submitted by students, some bank accounts were corrected. However, it has been noticed there are many students, whose payments have failed and they have not received their scholarship so far.

Keeping in view the interest of students, it has been decided to give a last opportunity to students, who have not received their scholarship due to following reasons:

1. Name mis-match (*Name as given in other documents/online application does not match with the name as recorded in the bank account*).
2. Bank account is not Aadhaar verified/linked.
3. Bank account number is not correct.
4. IFSC code is not correct.
5. Bank account is in other's name (*Joint account is however accepted if one of the name is of candidate*).
6. Bank account is not operational.
7. Any other reason, not mentioned above.

Therefore, the students, whose payment has failed, are advised to send their correct bank details in the prescribed format (attached). After verification of the same at institute level, a scanned copy of the same may be forwarded by the 'Institute Nodal Officer' through email to nsugcl@gmail.com. A scanned copy of Bank passbook may also be attached. The last date for receiving the application is **10.12.2020**. This will be the last opportunity for correction of bank account details.

The students selected under the schemes (i) 'Ishan Uday Special Scholarship Scheme for North Eastern Region-2017-18' (ii) PG Indira Gandhi Scholarship for Single Girl Child 2017-18, 2018-19 and 2019-20 (iii) PG Scholarship for University Rank Holders 2017-18, 2018-19 and 2019-20.

It may be noted that any request, not sent in the prescribed format, will not be considered at this end. Also incomplete/ambiguous /not readable applications will not be considered for correction. The request should be emailed by Institute's Nodal Officer through his/her official email ID. Any other request, which is not related to change of bank account, sent to designated email ID will not be considered. Correction in the bank account is allowed only once.

For the students of (i) Ishan Uday and (ii) PG Scholarship for SC ST students for Professional Courses of the selection years 2018-19 and 2019-20, the corrections can only be made by students themselves after receiving SMS from NSP. SMS is being sent separately to such students. Therefore, any request for change of bank account for the students of selection year 2018-19 and 2019-20 will not be considered through email etc.
