Resolution No 4/2022: The Academic Council has considered the case of Ms. Rupali Sharma, a Ph.D. Candidate-2021, who took admission but could not attend the classes of Pre-Ph.D. Compulsory Course work due to road accidental tragedy with her & her family and due to her severe injurious health issues. Having considered the medical certificate produced by her and her previous educational background, treating it as an exceptional case, it is resolved to allow her to join the classes from the session 2022 by depositing the compulsory course fee again. And that it will not be precedent in future.
